

GO ZERO Incentive Program for Zero-Emission Appliances MULTIFAMILY REBATE APPLICATION FORM

Thank you for your interest in participating in the South Coast AQMD GO ZERO Multifamily Incentive Program. Rebates are for eligible heat pump appliances installed on or after June 13, 2025, and are offered on a first-come, first-served basis when funding is available, for the pilot phase. If you have not completed the installation and would like to apply to reserve a rebate, please visit www.GOZEROMultifamily.com, or contact Willdan at (844) 437-0481 or GOZEROMultifamily.com.

1. Eligibility Requirements

- Residential building with 5+ dwelling units within South Coast AQMD geographical boundaries (verify at: www.aqmd.gov/home/about/jurisdiction).
- Applicant may be an owner or property manager. An installer may apply on behalf of an owner or property manager by completing this PDF application and required documents (see #2 below), then submitting to GOZEROMultifamily@willdan.com.
- Heat pumps replacing gas or propane furnaces or gas water heaters must be Energy Star certified. This requirement may be modified during the pilot phase if the Energy Star program ends.
- Applicant may elect for the rebate to be paid to the Installer by signing the relevant section at the end of this application.

2. Required Documents (all forms are available at www.GOZEROMultifamily.com)

- · Installer's invoice, which must include:
 - Itemized costs for: Labor, Equipment, Electrical Upgrade(s), Permitting, and Other.
 - Model and associated Serial Number for each unit installed.
 - Rebate amount must be included if it will be issued to the Installer.
- IRS Form W9: Must be completed by the person or entity that is receiving the rebate.
- Electronic Funds Transfer (EFT) Authorization form (OPTIONAL): This enables Willdam to directly deposit the rebate and should be completed by the person or entity that is receiving the rebate.

3. Eligible Equipment and Rebates

• Use the applicable Rebate Code to complete the Appliance table below. Multiple space heating/cooling units servicing one dwelling unit are counted as one heat pump for rebate purposes. The total rebate will be capped at \$300,000 per property during the GO ZERO Pilot Phase. If multiple applications are submitted for the same property during the GO ZERO Pilot Phase, the cap will be based on the cumulative total.

TERMS & CONDITIONS

- Funding is limited and submitting a rebate application does not guarantee you will receive a rebate. Rebates are for eligible space and/or water heating appliances installed on or after June 13, 2025, and are offered on a first-come, first-served basis when funding is available.
 - a. Funding may be made available in additional phases.
 - b. The start and close of rebate offer period for each phase will be announced by South Coast AQMD notice(s).
 - c. Applications submitted after the end of a phase but prior to the start of a potential future phase will be denied.
 - d. Applications received prior to the close of rebate offer period, but had no rebate issued due to a limitation of funding will be notified by South Coast AQMD if/when additional funding is available so that you may reapply.
- 2. Rebate amounts and general funding budget amounts are subject to change without notice.
- 3. A rebate issued from this program, in combination with other incentives available, shall not exceed the total project cost. The South Coast AQMD and/or Willdan reserves the right to adjust the GO ZERO rebate for this purpose.
- All rebated appliances are subject to a virtual or on-site inspection at the discretion of South Coast AQMD and/or Willdan. If the installation cannot be verified, the application will be denied.
- South Coast AQMD is not responsible for any taxes, fees, or tariffs that may be imposed as a result of the purchase/ installation of appliances.

- 6. Neither Willdan nor South Coast AQMD make any representations or warranties relating to the appliances referenced in this program, including but not limited to any hazardous substances that may be contained in the appliance, the quality or longevity of the appliance.
- 7. Applicant waives and releases Willdan and South Coast AQMD and any or all contractors or agents from any and all claims and causes of action arising out of the installation and use of appliances pursuant to the GO ZERO Incentive Program.
- 8. The qualified appliance must be installed before submitting the rebate application. Funding is available on a first-come, first-serve basis and it is encouraged that Applicants apply as soon as possible.
- 9. Willdan offers payment in the form of a mailed check or Electronic Funds Transfer (EFT). Checks will expire 90 days from the date issued, after which a stop payment may be issued. Funding from South Coast AQMD may not be available after the 90-day period, and Willdan may not be able to re-issue payment.
- 10. Rebate payments may be subject to state/federal income tax and are the responsibility of the Rebate applicant.
- 11. Rebate applications must be complete per the instructions above and are subject to verification and review for accuracy, including any additionally required documentation and/or inspections.
